Doing so may cause ruts in the grass, cracking of concrete, loss of vegetation, damage to underground sprinklers, drain fields, or other damage. Grubb Movers, LLC is not responsible for any damages or towing charges which may result, whether foreseeable or not.

_____ **Loading/Unloading:** Grubb Movers, LLC is not responsible for any damages which may occur in transporting the furniture and is released of all liability after loading the truck or prior to unloading.
